Austro Control Exam Guide

Student Portal & Application Form Instructions

How to book your Austro Control theory exams with Orbit Groundschool, complete the Application Form, and prepare for exam day.

Booking your exams

A new booking and a new Austro Control Application Form are required for **every exam week**.

01 Select your exam week

Open **Book exam** and choose an available exam week — the first step of every booking. Future weeks may appear before they open. If a week is full, a waiting-list reservation may be offered.

A waiting-list reservation is not a guarantee of an exam place. If a suitable place becomes available following a timely cancellation, it may be assigned to an appropriate candidate on the waiting list.

02 Select your exams & check your details

Select the exams you want to take and check your personal and address details. A valid **passport or ID card** must be present in the [Student Portal](#). “**Other Flight School**” is the training organisation (ATO/DTO) where you follow your theory training — not where you sit your exams.

Orbit contacts you using your **Student Portal email**. You cannot change this address yourself — [contact Orbit](#) if it needs changing.

03 Complete & upload your Application Form

Download the **Aeroplane** or **Helicopter** form during booking and upload it in the same booking. If your theory training organisation isn't Orbit, that organisation completes/signs the relevant sections. Full instructions on pages 4–7.

Complete the form digitally and in full. Handwritten forms are not accepted.

04 Review & pay

Check your application, submit it and pay immediately as part of the booking.

Note — your booking can only be processed and scheduled after successful payment; until payment is completed, no exam place can be scheduled. Successful payment does not by itself mean your exact exam schedule is already confirmed.

05 Orbit reviews & schedules

Orbit reviews your application and documents, and may ask you to correct anything incomplete. **Orbit determines the exact days and time slots** of your exams within the exam week you selected. Once confirmed, your schedule is visible in the Student Portal.

Good to know

The essential rules for booking correctly and attending your exam.

WHEN BOOKING

- Each exam week you attend counts as **one sitting**.
- **ATPL / CPL / IR / CB-IR**: maximum 6 sittings.
- Maximum **4 attempts** per examination paper.
- All required exams must be passed within **18 months**, counted from the end of the month of your first exam.
- A retake cannot be taken in the same sitting.
- A new sitting means a new booking and a new Application Form.

PPL

- All 9 PPL exams are taken in the **first sitting**.
- They are completed **on one day**.
- Required retakes are taken together in a later sitting.
- Enter the correct next sitting on the Application Form.

For other licences, exams may be scheduled across several days depending on their number and duration.

Appeals — submit during the exam using the comment box for the relevant question. Appeals cannot be submitted afterwards.

Exam durations

Maximum examination time per subject.

The times below are the **maximum examination times per subject**. They are different from Orbit's exam-day time slots (page 2). Shown as hours:minutes — **1:30 = 1 h 30 min**. **(A)** = aeroplane, **(H)** = helicopter; a single value applies to both, a blank means the subject is not examined for that licence.
